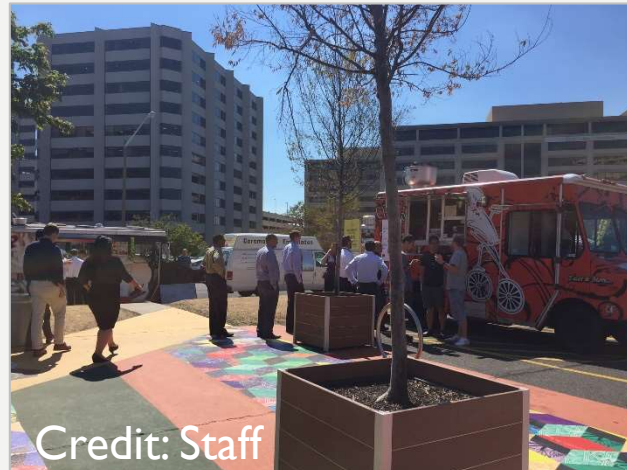
BACKGROUND

The Fairfax County Office of Community Revitalization (OCR) and the Fairfax County Park Authority (FCPA) are seeking community input on the vision for a new, innovative community gathering space in downtown Annandale. The County plans to repurpose a portion of the parking lot on property that it owns at 7200 Columbia Pike into a park/civic space. The County is interested in creating a park space that can be expanded for intermittent or “pop-up” programming and special events during weekends and evenings. Communities all across the country are exploring the placemaking power of such projects in an effort to bring people together and contribute to the vibrancy of an area.

CONCEPT

- The creative use of existing assets can provide civic gathering spaces in places which lack such infrastructure

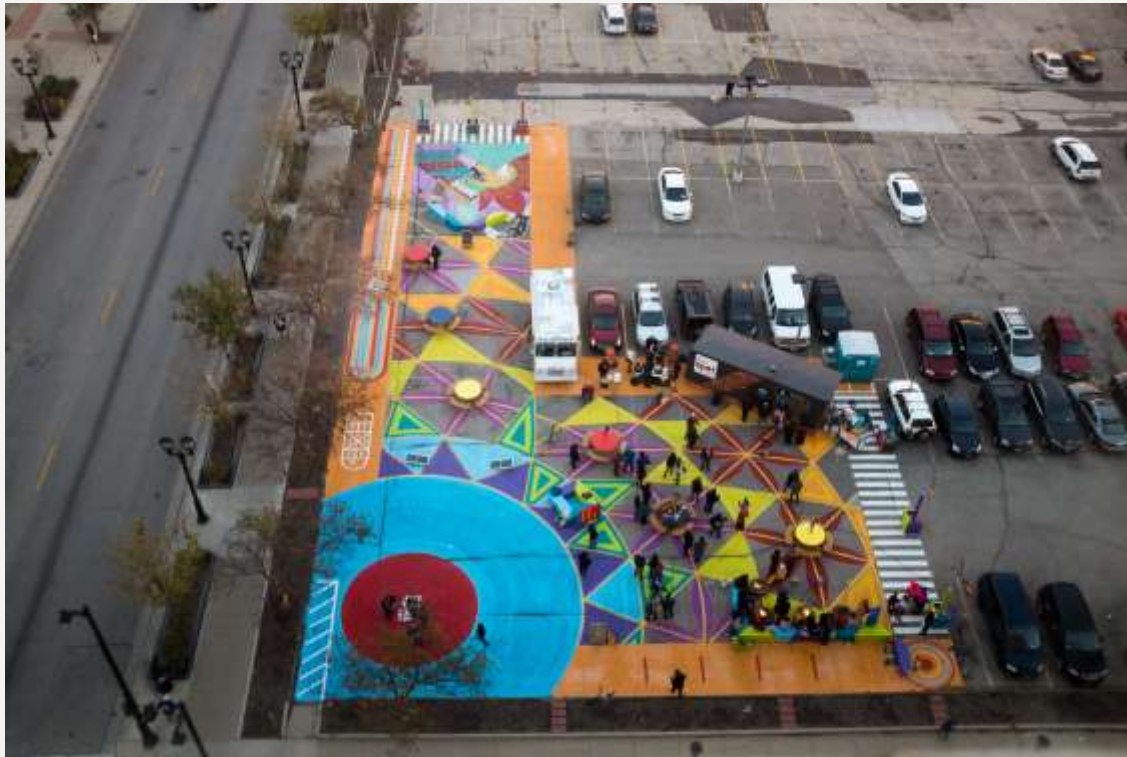

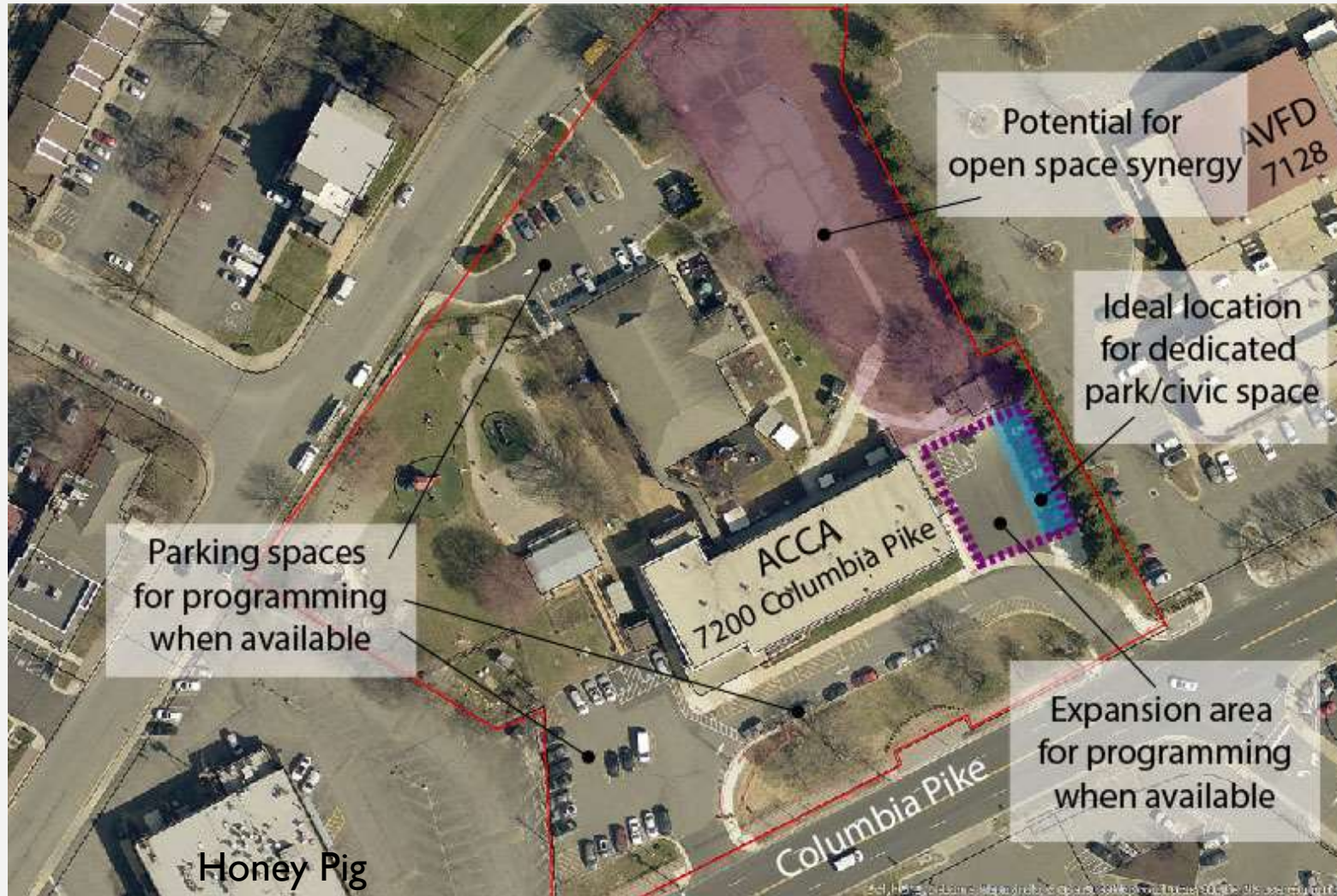

WHAT IS A “DEMONSTRATION PARK”?

- The County will host a “demonstration park” and use it as a creative venue for the community to visit and provide input on the proposed innovative new park/civic space at 7200 Columbia Pike:
 - The demonstration site will host a temporary park consisting of moveable elements like tables, chairs, landscape materials, etc., for the community to experience in-person
 - The demonstration site will also host tents and tables with information and visioning activities. The activities will help identify community:
 - Priorities
 - Questions/Concerns
 - Design Ideas
 - Programming Ideas
 - The demonstration site will also feature select programming activities to enliven the space (e.g., a game, children’s activity, or fitness class)
